Risks

Therefore, the Facility Recipient should ensure that the API credentials (API security key) and transaction data are always stored properly.
- The Facility Recipient will be charged a minimum monthly API BCA fee if the API BCA utilization is below the agreed minimum utilization of the API.

Requirements and Procedure

 - Sign the API BCA Facility Form and the Terms and Conditions for API BCA.
 - o Provide other supporting documents in accordance with the provisions applicable at BCA.
 - Carry out the application system development, testing with BCA, and implementation according
